Over the years she has been a regular member or Chair of the Boards of Statutory Auditors of listed and non-listed companies and Public Interest Bodies, Boards of Auditors of Local Authorities, Public Bodies, Local Health Authorities and Hospitals and Non-Profit Bodies, as well as Member or Chair of Supervisory Bodies.

She has edited, as scientific coordinator, author and co-author, publications of a professional nature and has been a speaker at conferences promoted by her own Professional Association. She has participated in study groups on the subject of control, social reporting, technical and regulatory expertise for Public Bodies and the Third Sector.
